Thank you for your email of 23 June 2021.

Effectively, and based on an application of s.158 of the *Fair Work Act 2009* (the "Act"), the Real Media Collective does not strictly fall into either of those categories of capacity.

Nonetheless, and due to the current and potential ongoing effects of COVID on the population and businesses, and as an interested party given our membership applies the terms of the Graphic Arts, Printing and Publishing Award (the "Award") in their workplaces, we continue to see the potential benefit for employees and workplaces from the reinstatement of the expired Schedule X into the Award.

Therefore, we urge the Commission to consider exercising its powers under s.157(3) of the Act, or an alternative, to reinstate the terms of the now expired Schedule X back in the Award and until December 2021. We therefore ask the Commission to consider our filed submissions for that purpose.
