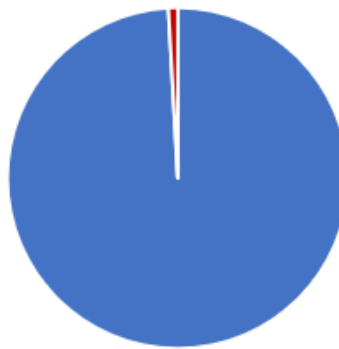

- No - 1 (0.9%)

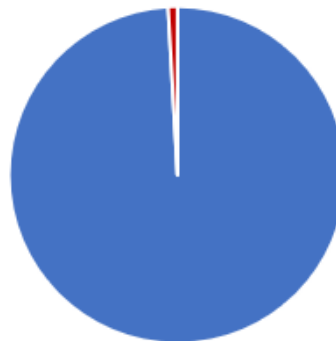


Question 2

- No - 1 (0.9%)

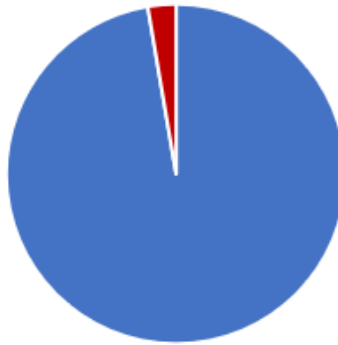

- No - 3 (2.7%)

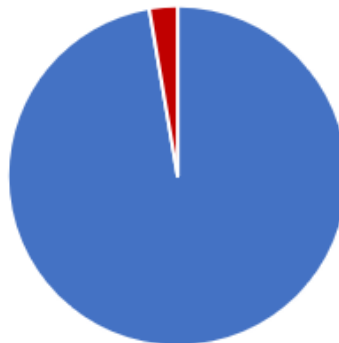

- No - 3 (2.7%)

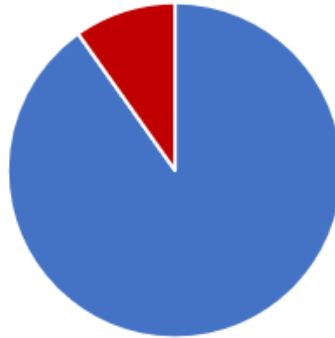

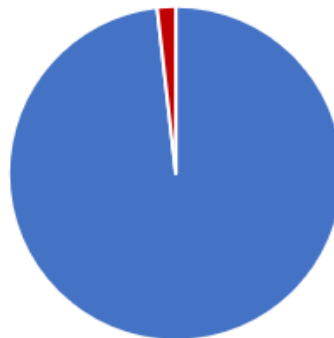

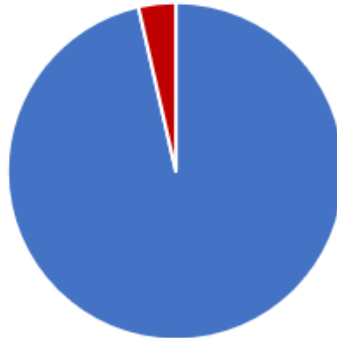

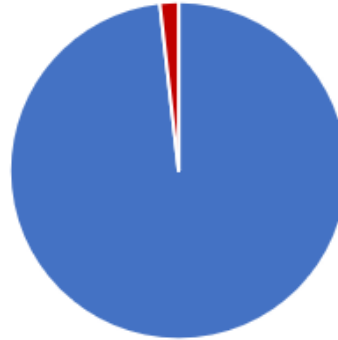

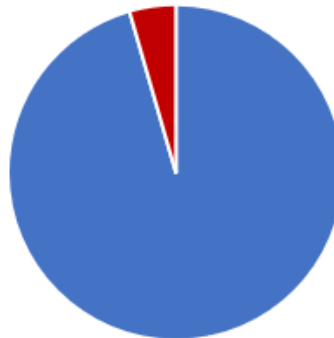

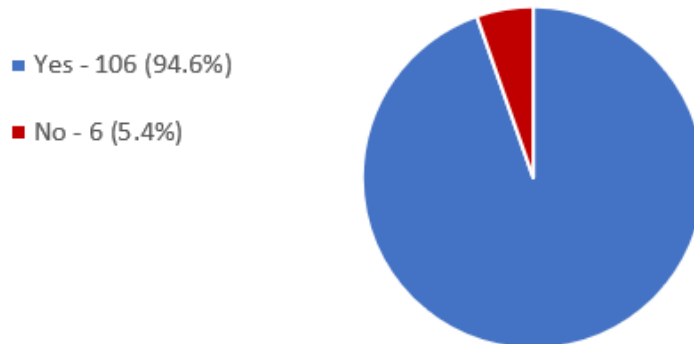

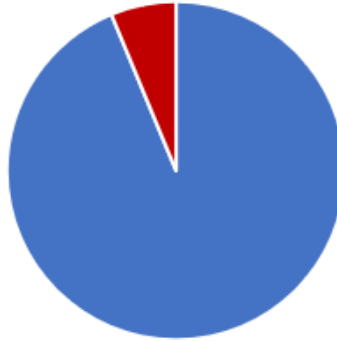

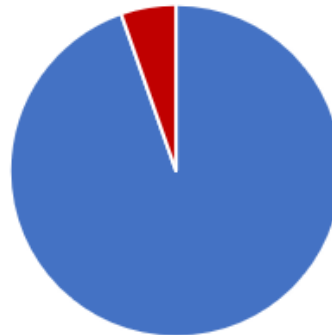

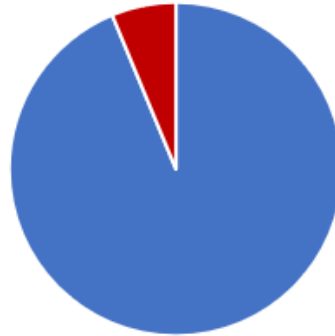

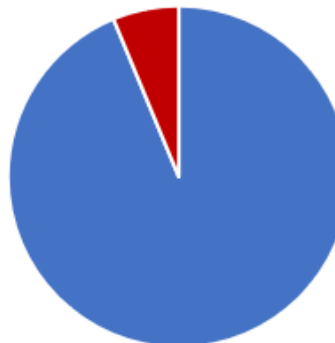

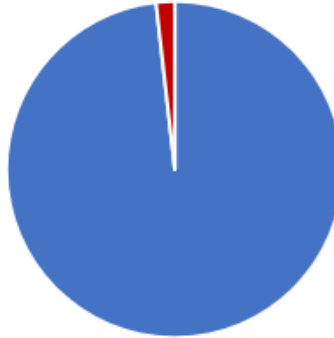

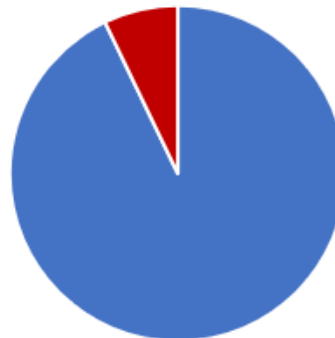

- No - 8 (7.1%)



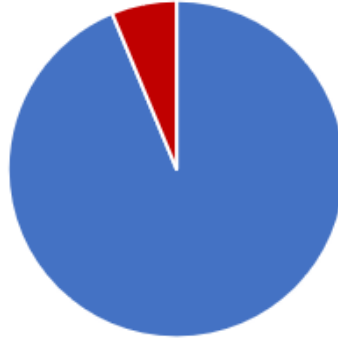

■ No - 7 (6.3%)



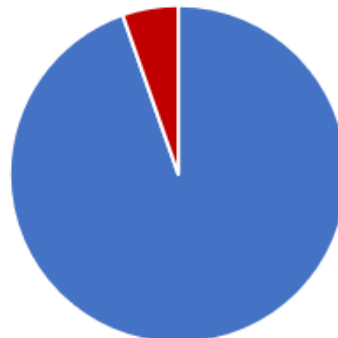
